The Valdez Eagles Hall was built in the early 1900's, the Eagles received their charter that established them as a local Aerie on July 13th 1911. The Eagles organization has been a active and important entity to the citizens of Valdez, living up to their mission of people helping people.

After the 64 earthquake which destroyed most of Valdez, the Eagles Hall survived and was moved to its present location where it has served as a movie theater and gathering place for the community, but it has been a long time since it has had a facelift.

The Eagle's Hall is located on a well-traveled street and visible intersection in the downtown corridor, the Aerie and Auxiliary hold events throughout the year that are attended by the community. This grant will help preserve a important part of Valdez History.

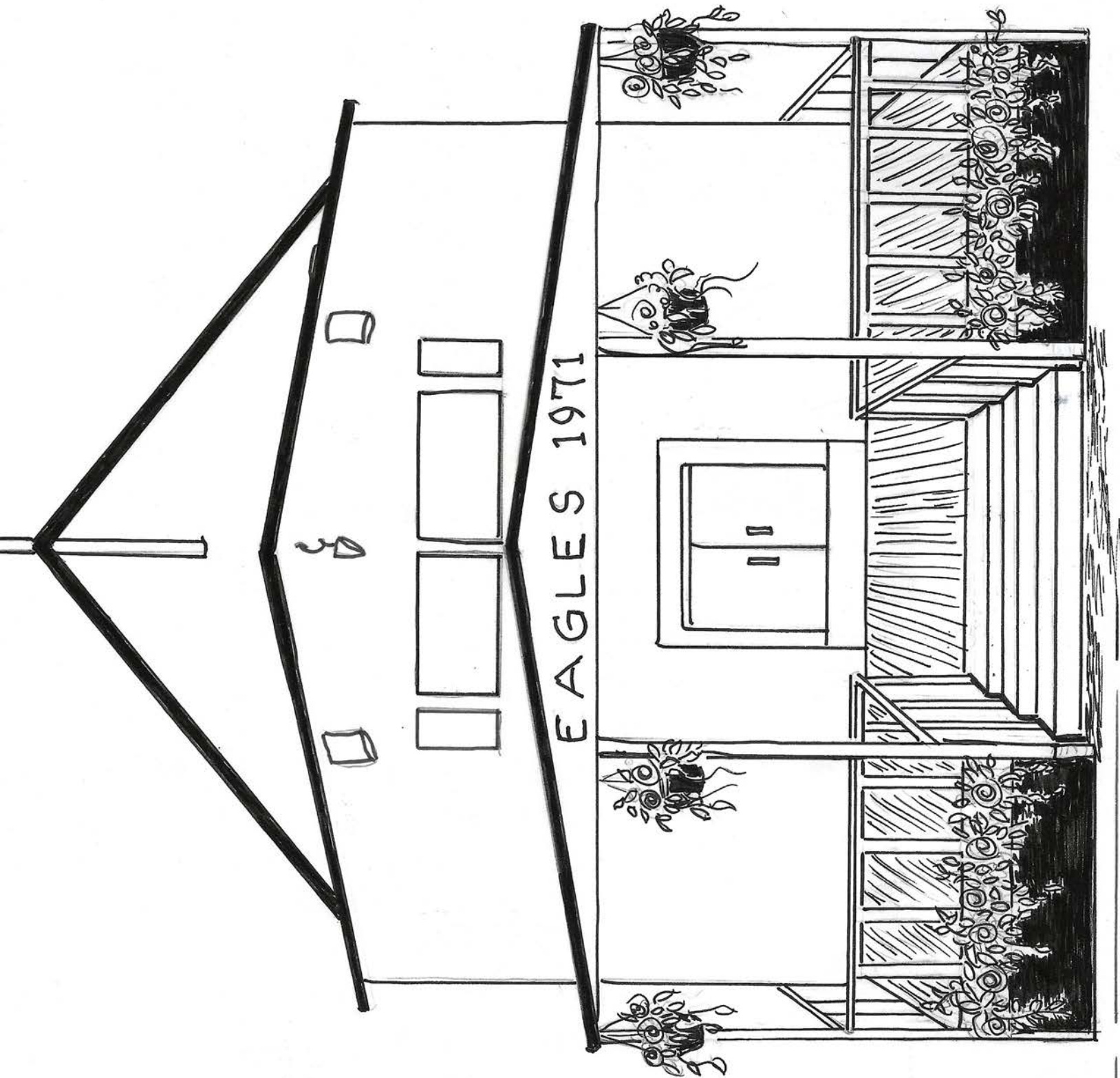
- 1) Remove old flower beds and brush around building.
- 2) Replace siding on building focusing on the front.
- 3) Remove satellite dish.
- 4) Relocate flagpole.
- 5) Expand covered area over entrance to run the full length of the building.
- 6) Widen and expand front porch to run full length of building.
- 7) Add hanging baskets, new flower bed along front of porch.
- 8) New lighting and signage to the front of the building.

Siding to be replaced on entire building if funds are available, focus will be on front facing street.

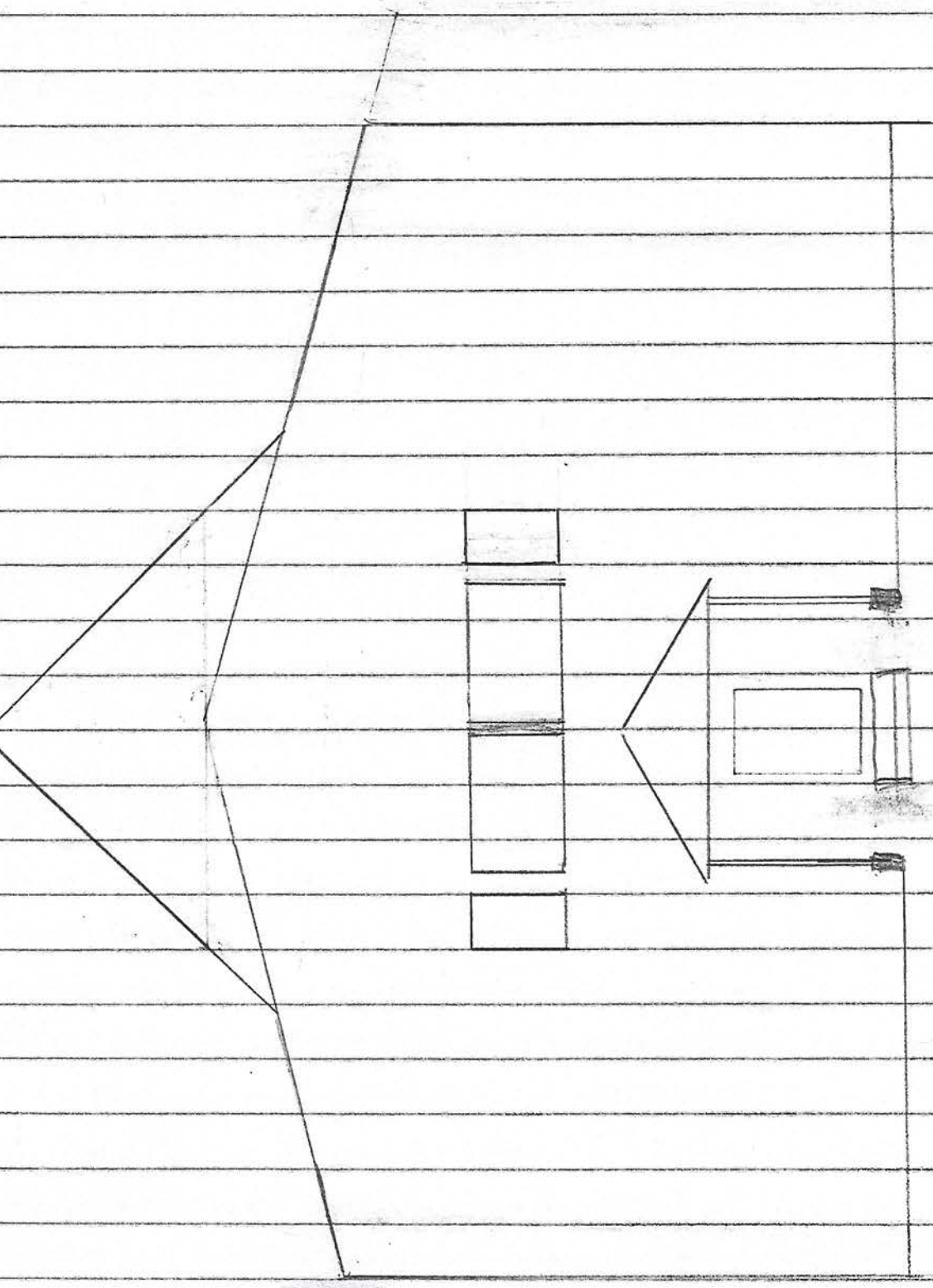
