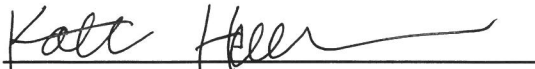

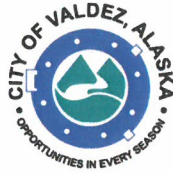

The Valdez Planning and Zoning Commission will hold a public hearing on Thursday, May 9, 2019 at 7:00 PM in City Council Chambers. The purpose of the hearing is to take public testimony on the request from Mary Mehlberg for a variance to allow construction of a retaining wall that is 12' high at the highest point on her parcels currently known as Lot 54 and Lot 55, Block 2, Mineral Creek Heights Subdivision (543 Cliffside Court & 555 Cliffside Court).

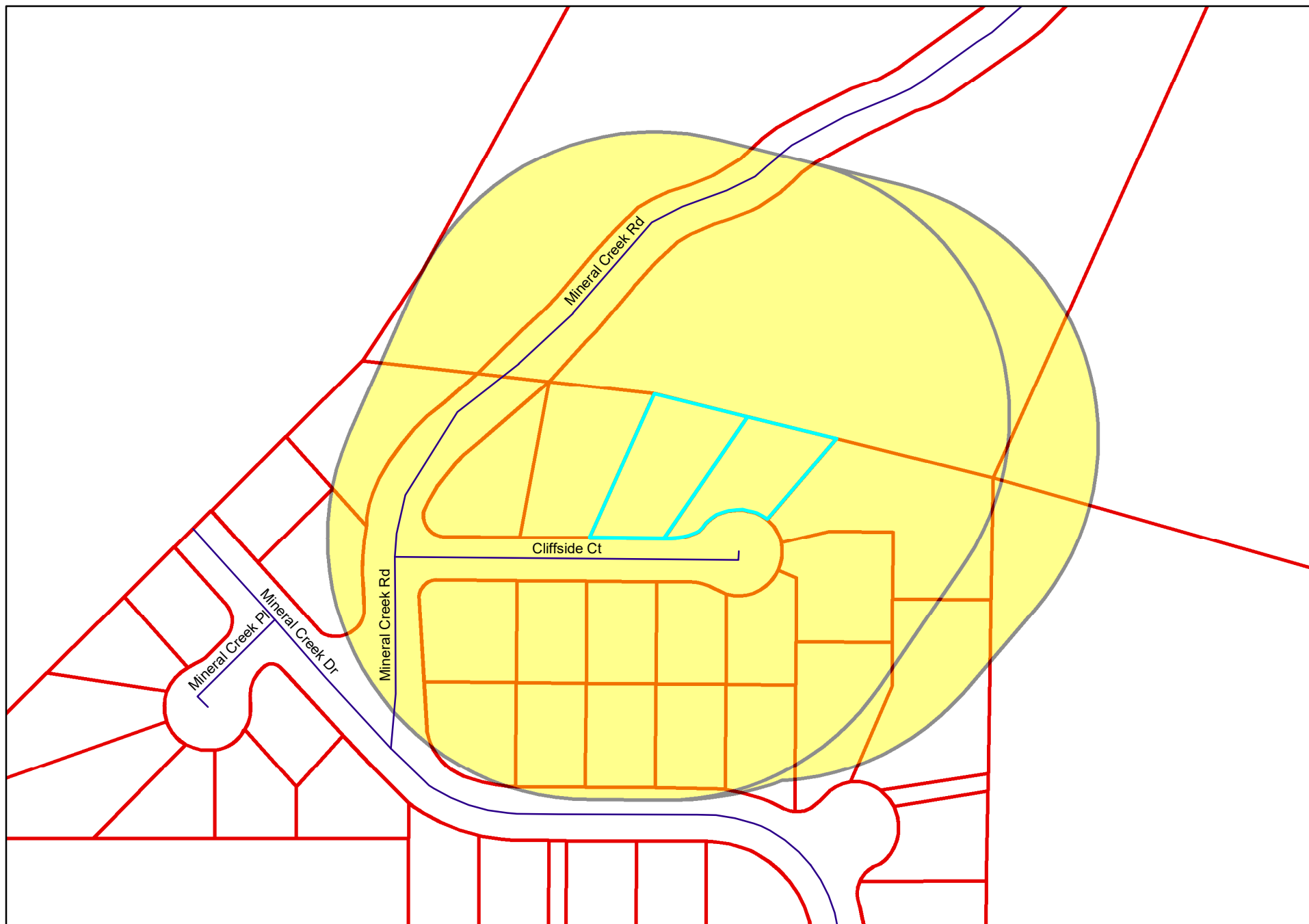
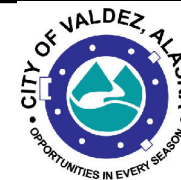
