As part of AMLJIA's ongoing commitment to serve its members, I visited the City of Valdez to field questions, inspect properties, and explain AMLJIA's services. I appreciate the time spent with you and other City of Valdez staff.

This report includes photographs of potential hazards with recommendations provided to help reduce the city's exposure to losses. The Action List included with the report must be completed, signed and returned within 30 days of receipt. The process is simple: document the date the hazard was remedied or a plan for future corrective action. These recommendations are a simple and useful tool for tracking your progress as the identified hazards are corrected. Completion of the Action List also earns credit in the Loss Control Incentive Program (LCIP). Participation in the LCIP can earn credit up to five percent off your annual contribution. In FY 19, the City of Valdez earned \$8,830 off its annual contribution through this innovative program! Thank you for your ongoing participation, this truly shows your commitment to keep your employees safe and exposure to risk at a low level.

The City of Valdez has \$588.85 in its AMLJIA Safety Savings Account that may be used for purchasing safety products. I recommend that you use these funds to purchase fire extinguisher signs to place above all fire extinguishers at the Civic Center and Library, and Exit signs for the Fire Station. I also recommend that you post safety rules and regulations at the shooting range visible enough for all users. Please feel free to call me if you would like assistance with these purchases. I am here to assist you with any safety concerns.

01-12219A: Civic Center, Police Station, Fire Station; Relocate obstructions away from electrical panel for easy access in the event of an emergency. Allow for a minimum of 30 inches of clearance around the electrical panel. In addition, keep electrical panels shut when not in use.



02-12219A: Civic Center (Theater); Replace batteries and lightbulbs to ensure emergency lighting activates in the event of a power outage.



09-12219A: Police Station (Stairwell); Replace broken electrical outlet cover to avoid arc flash, an electrical short, and live electrical exposure to employees.



10-12219A: Fire Station (Throughout Building); The building was inspected 3 years ago and diagnosed with a severe type of black mold. As indicated by the picture, certain areas have been quarantined due to black mold. Staff continue to work around the quarantined areas and state they feel sick after a day of work. During my inspection at this facility, I immediately experienced a headache that dissipated after I left. On May 6, 2019, the Valdez city council voted no on a proposal to relocate and construct a new fire station.

Recommend revisiting remediation plan(s) for current quarantined mold areas within building.

11-12219A: Fire Station; Exit doors are missing exit signs. Install appropriate exit signs above both doors. Exit signs should be illuminated to a surface value of at least five foot-candles (54 lux) by a reliable light source and be distinctive in color.



12-12219A: Airport: Improper means of entry into air handler room. Recommend installing pull-down staircase. Additionally, door should be marked to identify air handler room for authorized personnel only, and marked as not an exit.

13-12219A: Shooting range; Recommend users to sign-in prior to use and/or have users sign a waiver and statement of understanding of general range rules to keep on file. Additionally, install general safety range rules signs visible enough for all users to read, not posted in the line of fire.

Additionally, I recommend eliminating the hazard by selling the property to a local third party e.g., a gun club.



14-12219A: Shooting range; I was informed users often bring non-designated targets to the range to shoot; microwaves, tv's, etc. Recommend installing shooting range rule signs large enough for all users to read instructing users to only shoot at authorized targets (no exploding, glass, cans or other items considered trash targets).
