#### City Of Valdez Beautification Grant Application

Old Kelsey Building (New Gilson Dance Studio); 101 South Hazelet Ave.

#### **Project Description:**

Construct a Western style "4-Point" awning to the front of the building spanning the entire width of the building (20 feet) with 12/12 pitch to keep water and ice from infiltrating and accumulating on the front of the building. Awning will resemble similar styles found on buildings built around the turn of the 20<sup>th</sup> century. Building was constructed in 1916. Awning will be sided and painted to match the building color and will include metal roofing and additional lighting under the sofit to highlight the existing artistic stained glass.

The project will also form and pour a 4-foot wide half-circular concrete steps at the front entry along with a 4-foot wide sidewalk connecting the front entry steps to the sidewalk on Hazelet Ave. (An older, weathered concrete sidewalk previously existed, but was removed during renovation because of its poor state.) Sidewalk will be approximately 16 feet long.

#### Dear Kathy-

In July 2021, my wife Tracy and I purchased the Old Kelsey Building located at 101 S. Hazelet Street for the purposes of converting the old plumbing store into a dance studio. As you are aware, the building was from "Old Town" and only one of 50 structures moved over after the 1964 earthquake. Only eight of those were established as commercial buildings – the rest being located in residential areas. This makes our building unique for the Valdez commercial district.

We believe the building was constructed in 1916 – due to a fire that ravaged most of the commercial district in 1915. The museum staff concurred with that assessment. The building was used as the community's Post Office from 1916 to 1961, and then in new town, it was a place of business for a gun shop, Boutique Clothing Store (Ragtime), and a Heating and Plumbing store. As we began remodeling, we realized the previous owners left the building in very poor maintenance condition. We had to take the interior down to its studs in order to insulate, rewire, and replumb the entire building. In short, my wife and I made a considerable investment converting the building into a useable space for us.

Because of many cost overruns, we ran out of money for the front of the building – which was mostly decorative in nature. We would like to maintain the Old Western Front common on buildings during the turn of the 20<sup>th</sup> century. This grant would help assist us financially to build an Old Western Style Awning (which would also protect the front of the building from water intrusion) and help us establish concrete steps and a sidewalk to tie into the South Hazelet sidewalk. I believe this would greatly improve our property's appeal.

We are excited to make investments into our own property and, in doing so, restore a little bit of Valdez history in the process. Any assistance that you and the Valdez Beautification grant could provide would be greatly appreciated!
