THIS AMENDMENT between the CITY OF VALDEZ, ALASKA, ("City") and DEAN DAY DBA DAY ENGINEERING ("Consultant"), is to the following AGREEMENT dated the 1st day of October, 2019:

ARTICLE 1. Justification

The above referenced AGREEMENT requires modification due to the following requirements or conditions: Additional Construction Administration and Special Inspections, due to the delays encountered during directional drilling. Originally, all directional drilling work was to be completed in August 2024. Directional drilling work to now continue in late spring of 2025, there will be an additional two months of on-site special inspections needed that were not anticipated within the original design contract.

ARTICLE 2. Scope of Work - Period of Performance

Scope of work and/or Period of Performance to the above referenced AGREEMENT shall be modified as specified in the attached proposal dated <u>November 19, 2024</u>, which is hereby incorporated by this reference.

Amount Changed by previously authorized Amendment #1 and #2: \$3,456,600.00


