RESOLUTION #15-24

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, AUTHORIZING THE EXTENSION OF THE EXISTING UTILITY EASEMENT ON THE EAST SIDE OF THE BARNEY MEYRING PARKSTRIP, LOT 2, BLOCK 2, MINERAL CREEK SUBDIVISION TO 25 FEET AND GRANTING A NEW UTILITY EASEMENT ON THE WEST SIDE OF THE BARNEY MEYRING PARK STRIP

WHEREAS, the City of Valdez is the owner of the real property known as Lot 2, Block 2, Mineral Creek Subdivision; and

WHEREAS, Copper Valley Telecom has requested to increase the width of the existing 10 foot utility easement varying from 20-25 feet wide on the East Side of the Barney Meyring Park Strip; and

WHEREAS, Copper Valley Electric Association has requested a new utility easement on the West Side of the Barney Meyring Park Strip varying from 20-60 feet wide; and

WHEREAS, the utility installations shall be installed underground to provide for uninhibited use of the property; and

WHEREAS, extension of the utility easement is in conformance with the zoning and land use in the area, and the Comprehensive Plan; and

WHEREAS, on June 10, 2015 the Planning & Zoning Commission approved a recommendation to Council to grant these easements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, that

Section 1: The City Council grants a 20 foot wide public utility easement on the East side of the Barney Meyring Park Strip running North to South from Hanagita Street to Gulkana Street.

Section 2: The City Council grants a 25 foot wide public utility easement on the East side of the Barney Meyring Park Strip running North to South from Gulkana Street to Pioneer Drive.

Section 3: The City Council grants a 20 foot wide public utility easement on the West side of the Barney Meyring Park Strip running North to South from Hanagita Street to Oumalik Street.

Section 4: The City Council grants a 30 foot wide public utility easement on the West side of the Barney Meyring Park Strip running North to South from Oumalik Street to Nabesna Street.

Section 5: The City Council grants a 20 foot wide public utility easement on the West side of the Barney Meyring Park Strip running North to South from Nabesna Street to Mendeltna Street.

Section 6: The City Council grants a 60 foot wide public utility easement on the West side of the Barney Meyring Park Strip running North to South from Klutina Street to Jago Street.

Section 7: The City Council grants a 30 foot wide public utility easement on the West side of the Barney Meyring Park Strip running North to South from Jago Street to Iditarod Street.

Section 8: All utility installations shall be underground.

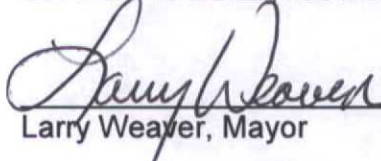
Section 9: The repair of all turf shall be made with 3-inch compacted topsoil, raked and seeded upon project completion at the expense of the utility companies.

Section 10: The cutting and patching of any asphalt shall be replaced with asphalt that stays with the current grade of the walkway.

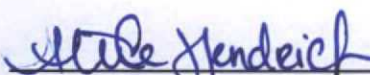
Section 11: Upon project completion, CVEA and CVTC will conduct a survey and re-plat that clearly delineates the new easements and vacates abandoned easements to be recorded in the Valdez Recording District at the expense of both CVEA and CVTC.

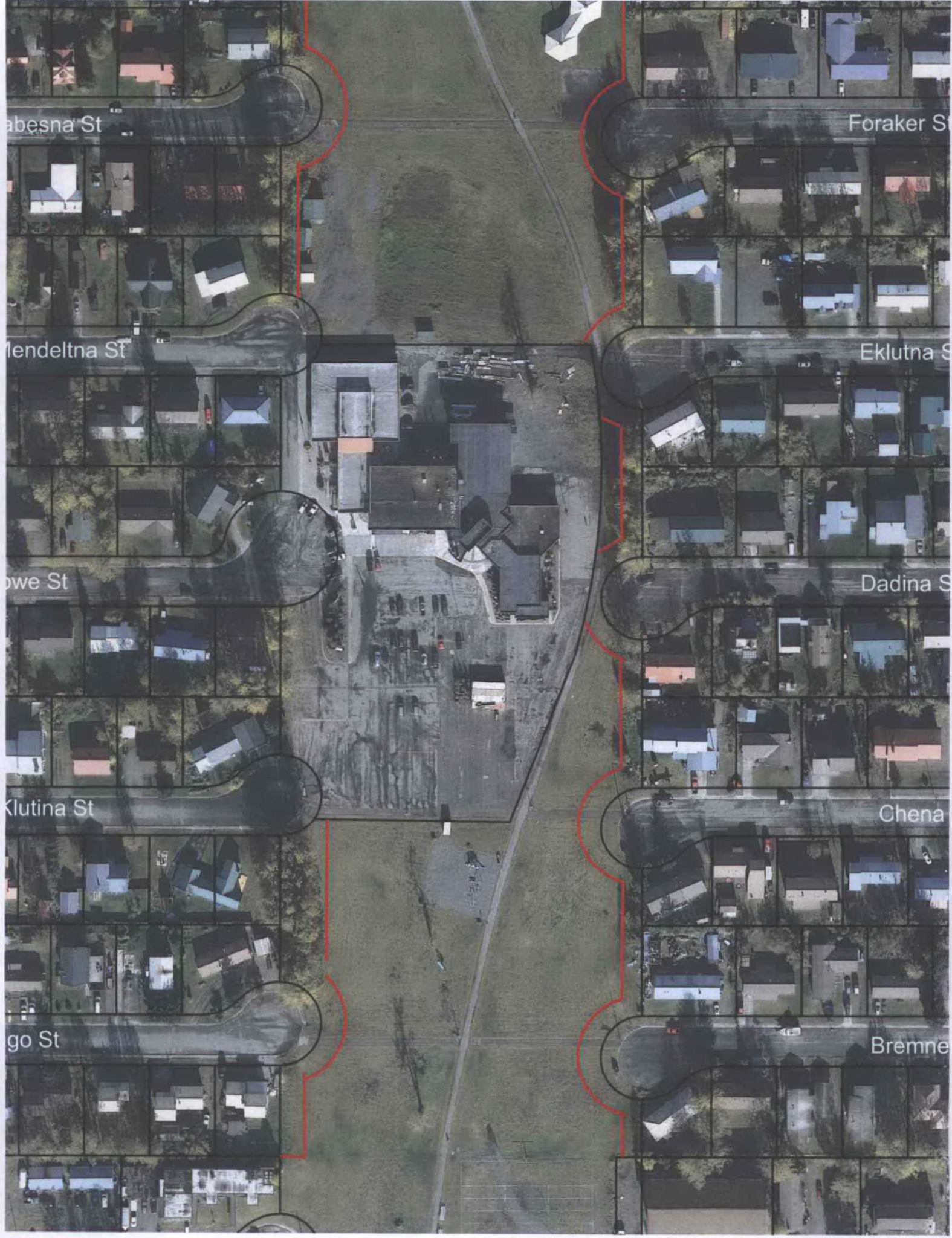

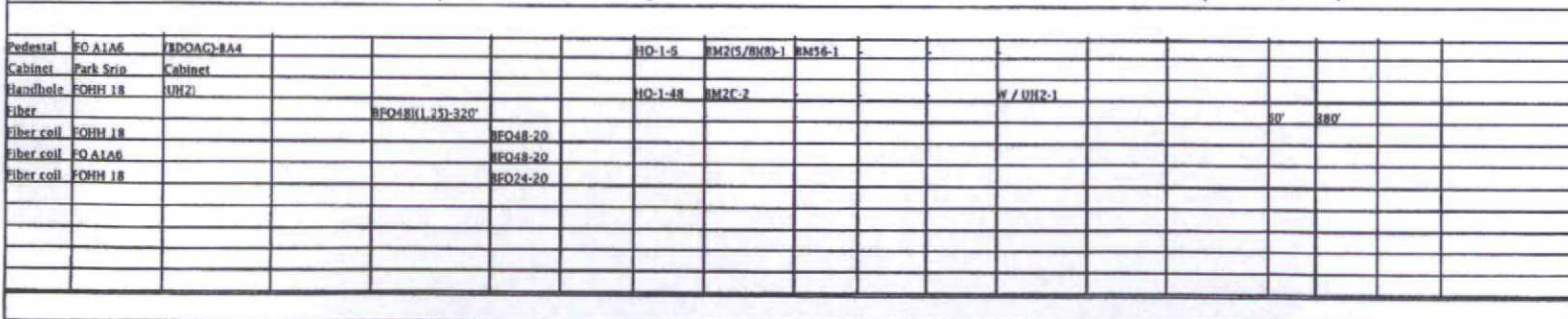

PROPOSED 2014 VALDEZ UNDERGROUND WORK

A) Existing underground feeds across the park strip will be abandoned in place

B) The new underground circuit will be fed from the Hazelet overhead line

C) New underground primary conductor will be 260mil EPR in 2" conduit

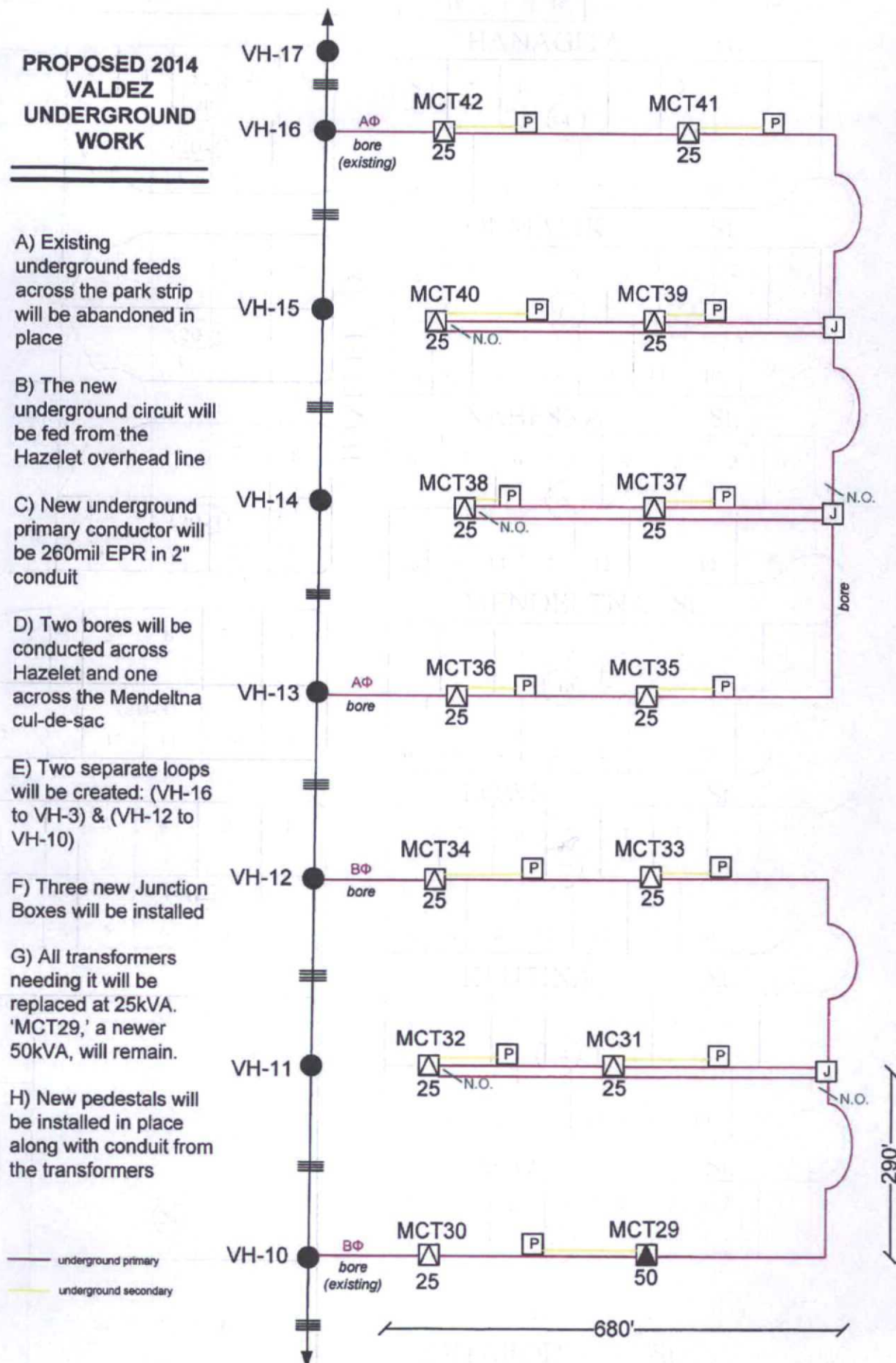
D) Two bores will be conducted across Hazelet and one across the Mendeltna cul-de-sac

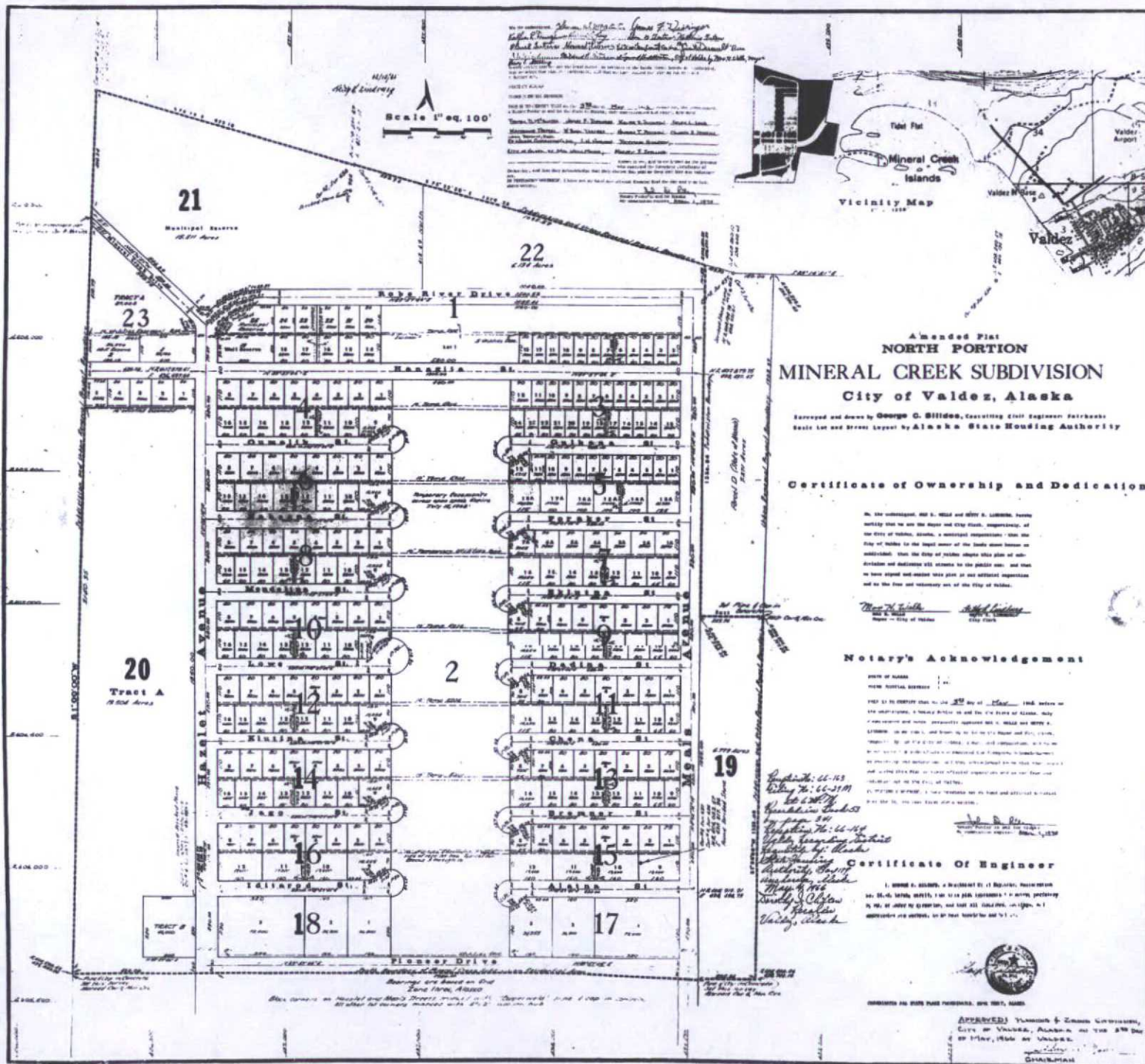
E) Two separate loops will be created: (VH-16 to VH-3) & (VH-12 to VH-10)

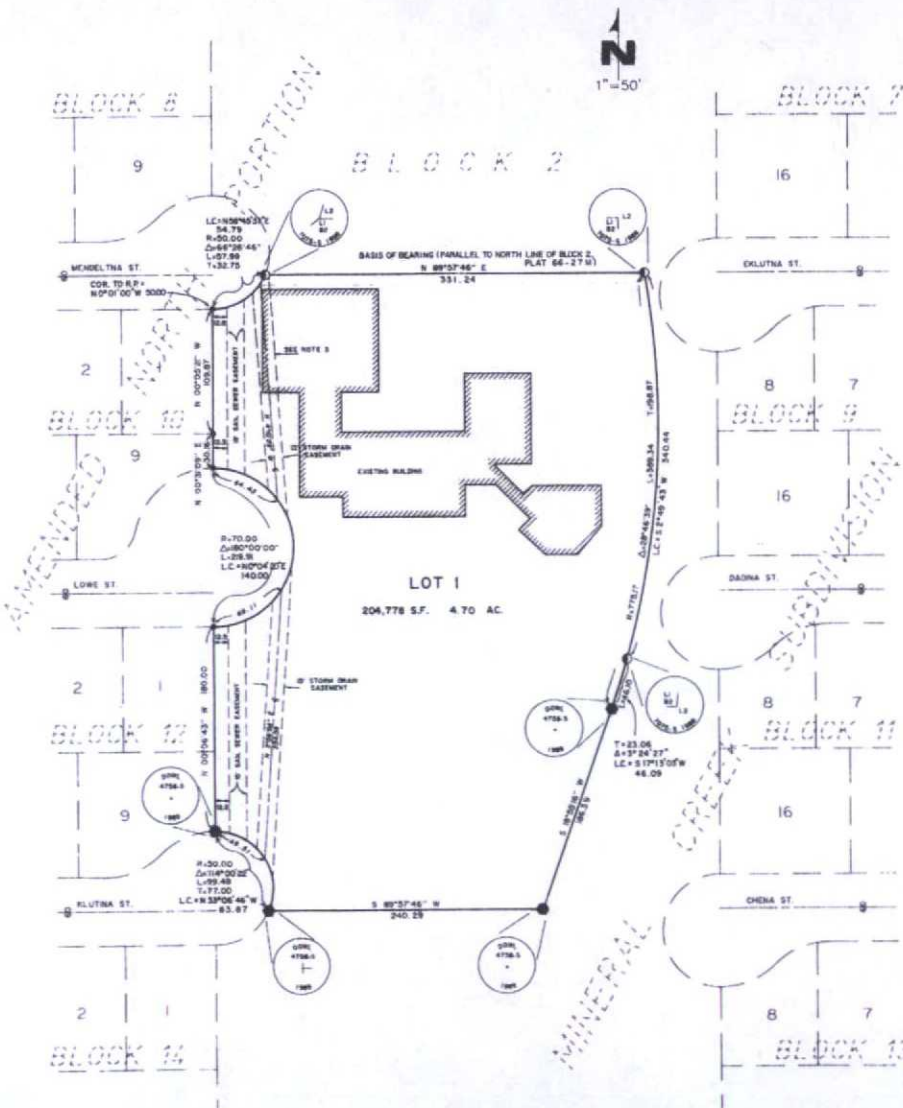
F) Three new Junction Boxes will be installed

G) All transformers needing it will be replaced at 25kVA. 'MCT29,' a newer 50kVA, will remain.

H) New pedestals will be installed in place along with conduit from the transformers

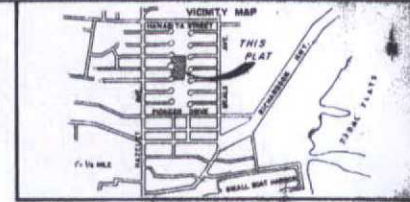
