

We made a decision on your VA benefits.

Dear Donald Disney:

This letter will guide you through the information you should know and steps you may take now that VA has made a decision about your benefits.

Your Benefit Information:

- Evaluation of residuals, status post right anterior middle cerebral artery stroke, with mild neurocognitive disorder, unspecified, without behavioral disturbances, which is currently 10 percent disabling, is increased to 50 percent effective August 18, 2022.
- Evaluation of residuals, portal vein thrombosis with cryptogenic hypercoagulability, status post small bowel partial resection with ileostomy, which is currently 0 percent disabling, is increased to 20 percent effective August 18, 2022.
- Service connection for status post mid and right abdomen scars is granted with an evaluation of 0 percent effective August 18, 2022.
- Evaluation of residuals, status post right anterior middle cerebral artery stroke, with left arm hemiparesis (minor), which is currently 20 percent disabling, is continued.
- Evaluation of residuals, status post right anterior middle cerebral artery stroke, with left leg hemiparesis with atrophy, which is currently 10 percent disabling, is continued.
- Service connection for post-phlebitic syndrome, left lower extremity is granted with an evaluation of 20 percent effective August 18, 2022.
