

# 1. #24-45 - Supporting the Alaska Salmon Hatchery Program

MOTION: Council Member Sorum moved, seconded by Council Member Scheidt, to approve Resolution #24-45.

Council Member Love requested additional information on the following topics:

- Clarification the proposed Resolution would support the hatchery in requesting the Alaska Board of Fisheries reject the proposed 25% reduction in egg take
- The proposal process for the Board of Fisheries
- Who makes up the Board of Fish, and the appointment process
- Who makes the final decision on hatchery production

Council Member Love expressed concern over Council getting involved with the process of fisheries management. He stated he did not feel Council had the scientific expertise to be involved in the process.

Council Member Love moved to postpone Resolution #24-45 indefinitely. Motion failed for lack of second.

Council Member Foster asked why the hatchery disagreed with the proposal. Mike Wells, Valdez Fisheries Development Association, provided a history of how the limits had been set in the last 40 years. He explained how acceptance of the proposal would move the decision process away from basing decisions on production on the department and the fishery scientists, to a political decision.

Council Member Sorum stated he believed it was Council's place to be involved due to the economic impact the hatchery has on the community.

Council Member Devens agreed Council did not have the authority or expertise to speak on scientific findings, and noted the majority of the language of the resolution was regarding the economic findings of the impact on the community.

Council Member Devens moved to amend, striking section two of the "now therefor be it resolved" to not reference any scientific finding in the conclusion. Motion failed for lack of second.

Mayor Fleming shared his support of the resolution, because it was important to keep politics out of a scientific decision. He shared his support of the fish hatchery.

Council Member Scheidt shared her support of the fish hatchery. She stated Council had a loud voice and this was a great opportunity to use it. She did not

feel passing the resolution would be Council involving themselves in the minutia or the science.
