This agreement is made on the _____ day of ______, 2022, by and between the City of Valdez, Alaska, hereinafter called the Owner, acting through its Mayor, and X-DLX Investments Corporation doing business as a corporation located in Valdez, Alaska, hereinafter called the Contractor.

The Contractor agrees to this Contract known as:

Furthermore the Contractor agrees to accept as full and complete payment for all work to be done in this Contract for the lump sum and per unit prices as set forth in the Bid Form and Addendums in the Contract Documents for this project. The total amount of this Contract shall be: one hundred seventy-four thousand, one hundred ninety dollars and zero cents (\$174.190) per year for the following schedules:

Group 1 Schedule A: Spring Clean Up – total bid for one year - \$36,815

Group 1 Schedule B: Watering – total bid for one year - \$9,300

Group 1 Schedule C: Mowing and Trimming – total bid for one year - \$105,200

Group 1 Schedule D: Fertilizing – total bid for one year - \$10,850

Group 3 Schedule B: Spring Clean Up – total bid for one year - \$12,025

Contract term shall be three (3) years with the option of two (2) one-year renewal options. This contract will expire September 30, 2024.

The Contractor hereby agrees to commence work on this project within ten (10) working days after the date of the written Notice to Proceed and to complete all work in accordance with the contract documents and addendums annually. Said contract documents are listed in the Table of Contents herein. All documents listed therein are by this reference made a part hereof.

The Owner agrees to pay the Contractor for the performance of the Contract, subject to additions and deductions, as provided in the City of Valdez Standard Specifications Section 10 Standard General Provisions of this Contract, and to make payments on account thereof as provided in the City of Valdez Standard Specifications Section 10 Standard General Provisions and City of Valdez City Code.
