V. PUBLIC BUSINESS FROM THE FLOOR

Joe Prax, Valdez resident, spoke on his concerns with the report provided during the Child Care Next Steps Work Session.

Faith Revel, Valdez Museum & Historical Archive Interim Director, thanked those involved in the museum's HVAC project and provided a brief update.

Council Member Love reviewed the committee's recommendation included in the packet.

MOTION TO AMEND: Council Member Love moved, seconded by Council Member Devens, to Amend Resolution #23-68 by the replacing references to appendix A with reference to the attachment in the agenda packet titled Committee Recommendation on Final Design Proposal.

John Clark of the Port Valdez Company provided the perspective of the company on the proposal. Clark noted that they did not object to the design but that additional expense was not covered under the project's current budget.

Council Member Wegner and Council Member Fleming asked who would pay for the additional EVOS side stone element of the proposal.

Deputy Clerk Sorum-Birk clarified that the item on the table was the approval of the design and noted that funding there would be a need for a future discussion and decision on funding.

Mayor Pro Tempore Sorum expressed his desire to have the EVOS story told because it was EVOS funds which were used to purchase the property.

Council Member Wegner asked what maintenance would be needed for the installation. City Manager Douglas stated it would be minimal maintenance.

Council Member Fleming asked if the lease would ever come to an end, and if not, would it be possible to sell the property to the lessee. Community Development Director Kate Huber stated as long as the parking requirements remained the same, she did not see the lease ending. Director Huber volunteered to look into the disposition of the land with Legal.

2. Discussion Item: Long Term Capital & Projects Planning

Finance Director Jordan Nelson reviewed his presentation outlining proposed adjustments to the project planning process, included in the agenda packet.

Council Member Love asked historically how long the carry-forward and projects funds have been repurposed within the CIP Fund. Director Nelson outlined the current and prior processes.

Mayor Pro Tempore Sorum asked if any momentum would be lost on potential new projects. Capital Facilities Director Nate Duval confirmed there would not be a lot of room to add projects for a year, and explained how it would benefit in the long run.

IX. ORDINANCES

1. #24-02 - Amending Chapter 10.12 of the Valdez City Code Titled Parking. Second Reading. Adoption.

MOTION: Council Member Love moved, seconded by Council Member Fleming, to approve Ordinance 24-0002, Second Reading. Adoption.

Council Member Devens expressed concern over the increase and cited research.

Council Member Foster noted the safety hazard created for the plow crew when cars were parked in the street.

Council Member Fleming shared his support for a stricter penalty.

Council Member Wegner shared his personal experience with animal impound fees, noting his own behavioral changes due to steeper fines.

Bart Hinkle, Chief of Police, requested that approval be postponed due to a need to review Ordinance #24-02 and Ordinance #24-04 side by side as he was concerned there was an oversight on how one would affect the other, and needed additional time to review both with Legal.

MOTION: Council Member Love moved, seconded by Council Member Fleming, to postpone Ordinance 24-0002 to the next regular meeting.

City Attorney Staser and Deputy City Clerk Sorum-Birk confirmed if there was an amendment at the next meeting, the ordinance would need to come back for an additional first reading and public hearing.

Valdez Resident Clay Strickland spoke in favor of postponing the ordinance.
