## ORDINANCE NO. 06-07

AN ORDINANCE OF THE CITY OF VALDEZ, ALASKA, AMENDING THE ZONING MAP TO EFFECT A CHANGE TO A PORTION OF TRACT C AND TRACT F, PORT VALDEZ SUBDIVISION FROM SINGLE FAMILY RESIDENTIAL TO MULTI-FAMILY RESIDENTIAL, WATERFRONT COMMERCIAL AND GENERAL COMMERCIAL

WHEREAS, the City of Valdez has received notice of a land sale and planned future development of a portion of Tract C and a portion of Tract F, Port Valdez Subdivision.

WHEREAS, the City of Valdez has received a request from Jack Roe to rezone a portion of Tract C, Port Valdez Subdivision from Single Family Residential to Multi-Family Residential (7.2 AC) and Waterfront Commercial (0.14 AC) and a portion of Tract F, Port Valdez Subdivision from Single Family Residential to General Commercial (5.4 AC) and Multi-Family Residential (5.8 AC); and,

WHEREAS, the rezone is necessary for the future development plans for these parcels; and,

WHEREAS, the City Council and the Planning and Zoning Commission determined that the rezones are in the best interest of the City of Valdez; and

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, that:

Section 1: Parcel 1 (7.2 Acres) of Tract C, Port Valdez Subdivision is hereby rezoned from Single Family Residential to Multi-Family Residential and Parcel 4 (0.14 Acres) of Tract C, Port Valdez Subdivision is hereby rezoned from Single Family Residential to Waterfront Commercial.

Section 2: Parcel 2 (5.8 acres) of Tract F, Port Valdez Subdivision is hereby rezoned from Single Family Residential to Multi-Family Residential and Parcel 3 (5.4 Acres) of Tract F, Port Valdez Subdivision is hereby rezoned from Single Family Residential to General Commercial.

Section 4: This ordinance shall take effect immediately upon passage and approval.
