FIRST AMENDMENT TO JANITORIAL SERVICES CONTRACT Contract Number: 1233.XDLX

This First Amendment To Janitorial Services Contract is made and entered into as of January 1, 2017, by and between the City of Valdez, Alaska ("Owner"), and X-DLX Investments Corporation, a Alaska corporation ("Contractor").

1. <u>RECITALS</u>

- a. Owner and Contractor, entered into a 2016 Janitorial Services Contract Number 1233.XDLX, dated as of December 1, 2015 ("Contract") under the terms of which, among others, Contractor agreed to perform certain janitorial services for Owner, as more specifically set forth in the Contract.
- b. Owner has exercised its option under the Contract to extend the term or the Contract for an additional period of one (1) year commencing January 1, 2017 and continuing through December 31, 2017.
- c. Owner and Contractor have agreed to certain amendments to the Contract applicable to the First Extended Term, as more specifically set forth below.
- d. Based upon the foregoing, Owner and Contractor, hereby amend the Contract as follows.

2. AGREEMENT

- **2.1.** Term. The term of the Contract shall be extended for an additional period of one (1) year commencing January 1, 2017 and continuing through December 31, 2017 ("First Extended Term").
- 2.2 As compensation for the janitorial services to be Compensation. provided by Contractor to Owner during the First Extended Term, Owner shall pay Contractor the total amount of One Hundred Thirty Eight Thousand Seventy and 25/100 Dollars (\$138,070.25) at the following unit prices: (a) Animal Shelter-\$8,137.00; (b) Harbor Building-\$9,167.00; **B-Float** Comfort Station-\$3,914.00; (c) Library-\$17,504.85; (e) Teen Center-\$22,654.85; (f) Airport Building and Capital Facilities Offices-\$43,048.85; (g) Seasonal Comfort Stations-\$14,409.70; (h) Goldfields Restroom-\$5,974.00; (i) Outhouses-\$5,356.00; and (j) Seven (7) Owner offices at Airport Building-\$7,904.00. Such compensation shall be paid in the increments provided for in the Contract.
- **2.3** All terms of the Contract not amended or restated as hereinabove set forth, shall remain in full force and effect.
