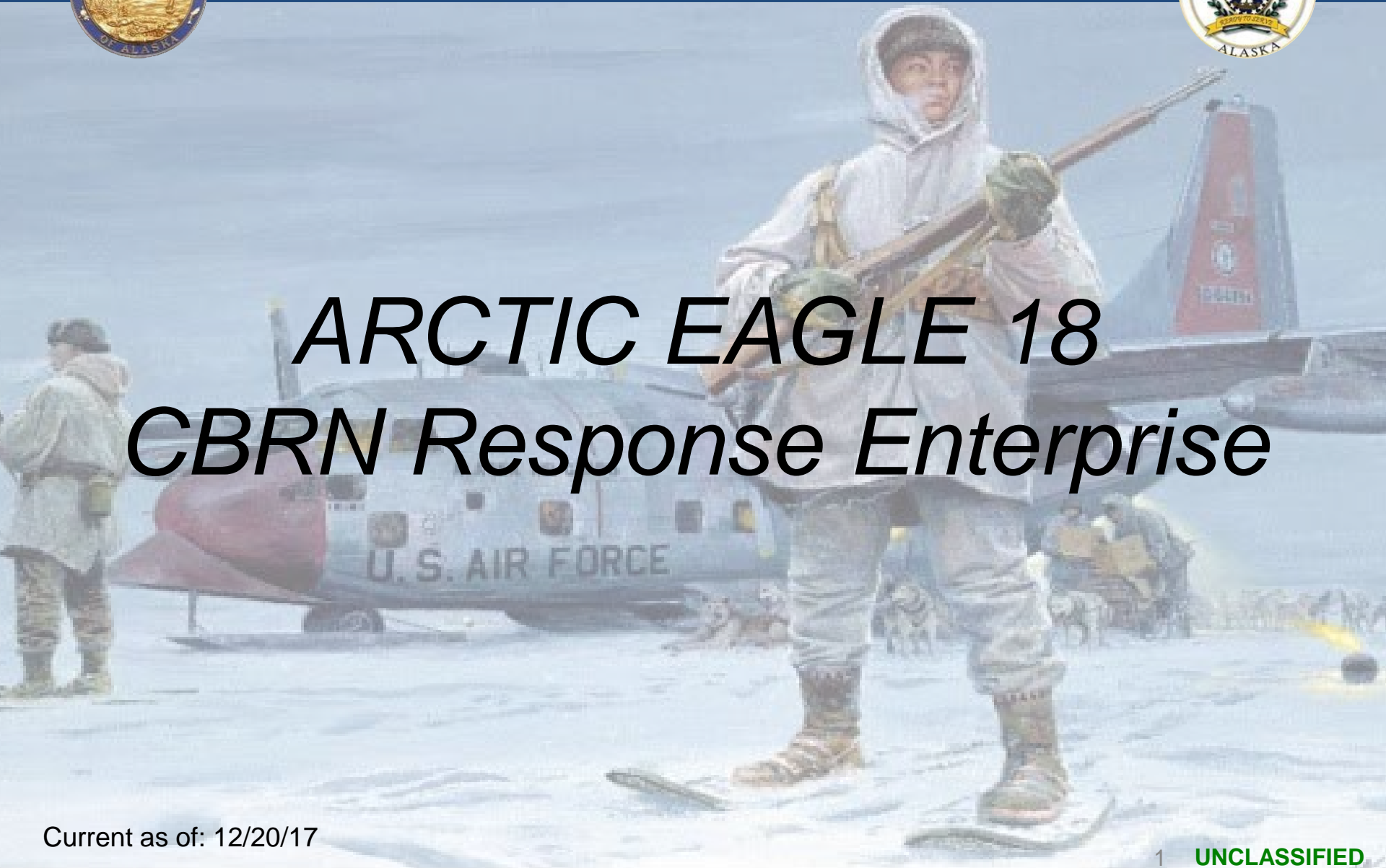




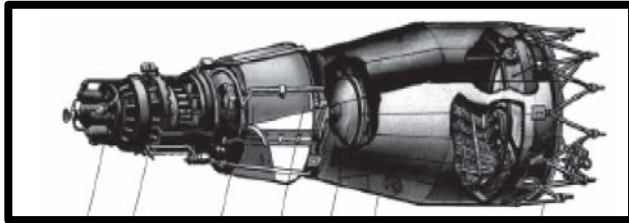

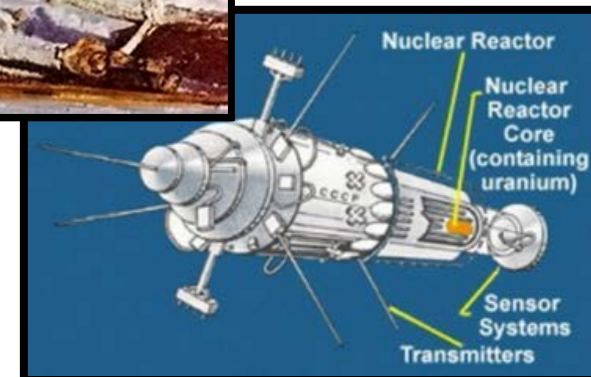


AE18 Scenario - Satellite



Satellite with enriched **U-235 Uranium Core** prematurely re-enters Earth atmosphere

- Kosmos 954 satellite failed in orbit in 1978, breaking up in the atmosphere and dropped radioactive debris over N. Canada
- Some ballistic risk
- **U-235: Alpha & Gamma particle hazard**
 - Insoluble in water
 - Ingestion of high concentrations can cause severe health effects
- Radioactive Debris Field: Few hundred pounds of irradiated chunks of material; debris could spread over land and ocean with a radius of ~ 370 miles.



AE18: CBRN Response Enterprise (CRE)

Mission: Consequence management operations in coordination with city of Valdez AK in order to exercise National Guard CBRN response with USCG assets to a radioactive & Toxic Industrial Chemical (TIC) incident.

Scenario: A communications satellite belonging to a foreign nation crashes in Alaska. Crash spreads radioactive material in and around Alaska, causes damage to structures, casualties, and contamination of the area. Port of Valdez impacts cause CONEX HAZMAT release

Concept: Satellite crash in Alaska brings in multiple CSTs, elements of the HRF, and USCG Pacific Strike Force on 21 FEB18. City of Valdez, USCG, AK DEC establish a Unified Command (UC); AKNG establishes JTF. Satellite crashes 22 Feb - Valdez/UC response; CRE mobilize 23 Feb + TIC event. All elements conduct AAR and MWR day 25 Feb; recover 26 Feb18.

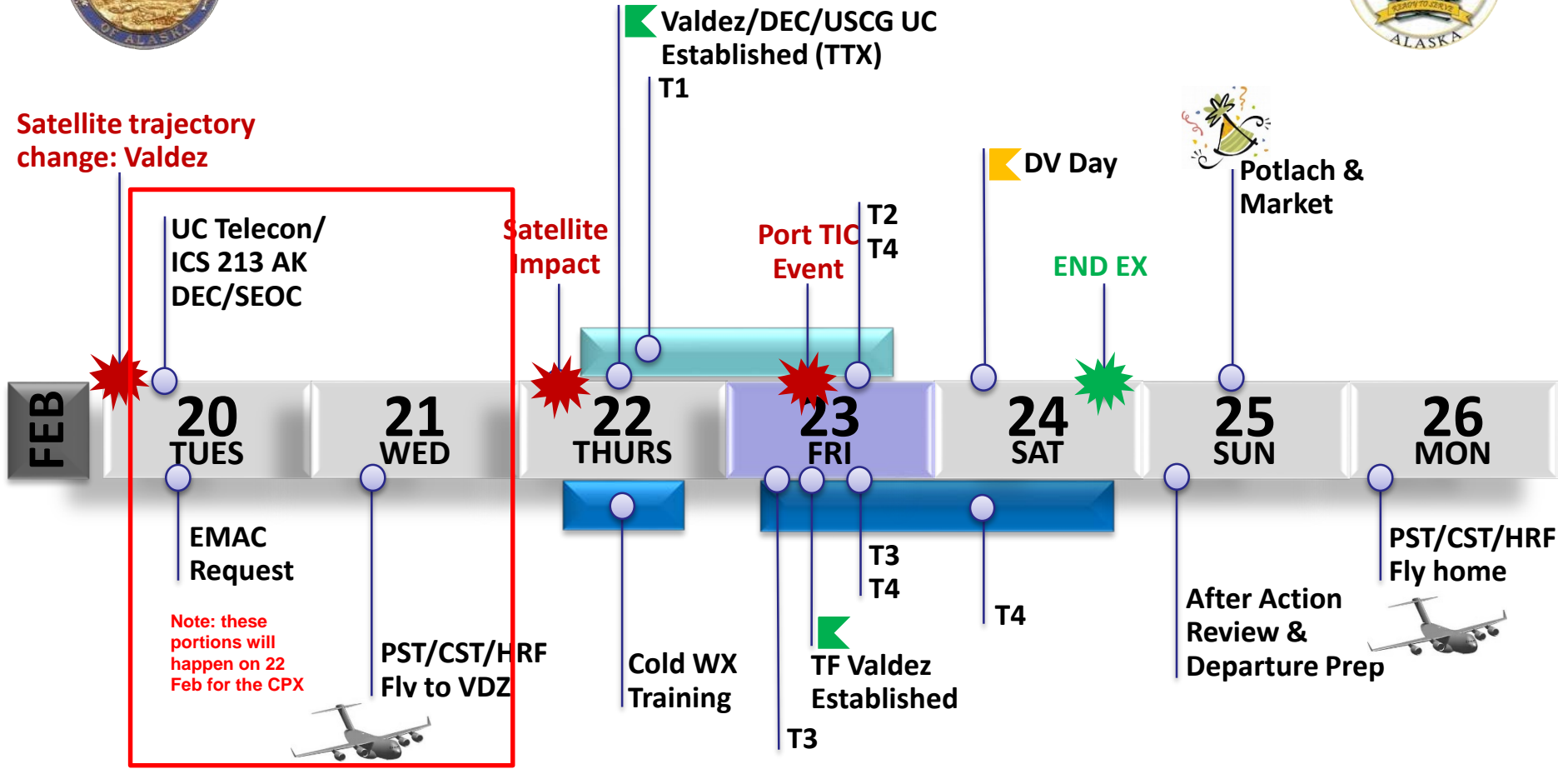

AE18 Valdez: Ferry

AK DOT is sourcing two ferry departures from Whittier to Valdez on 21 FEB 18 and returning from Valdez to Whittier on 26 FEB 18. This is the primary transportation for multiple agencies and alternate transportation for the 10th HRF.

Due to limited space, only those organizations that have pre-coordinated for space with AKNG J37 will be able to utilize the Ferry for transportation.
