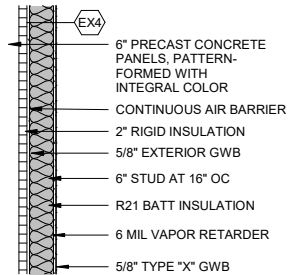

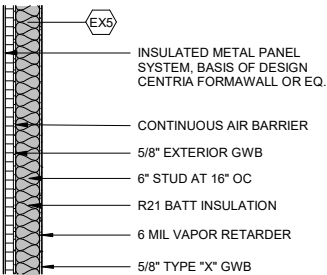

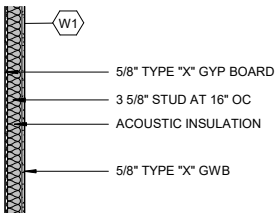

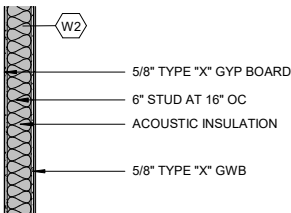

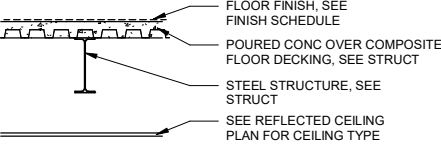


R1_ LOW-SLOPE ROOF ASSEMBLY

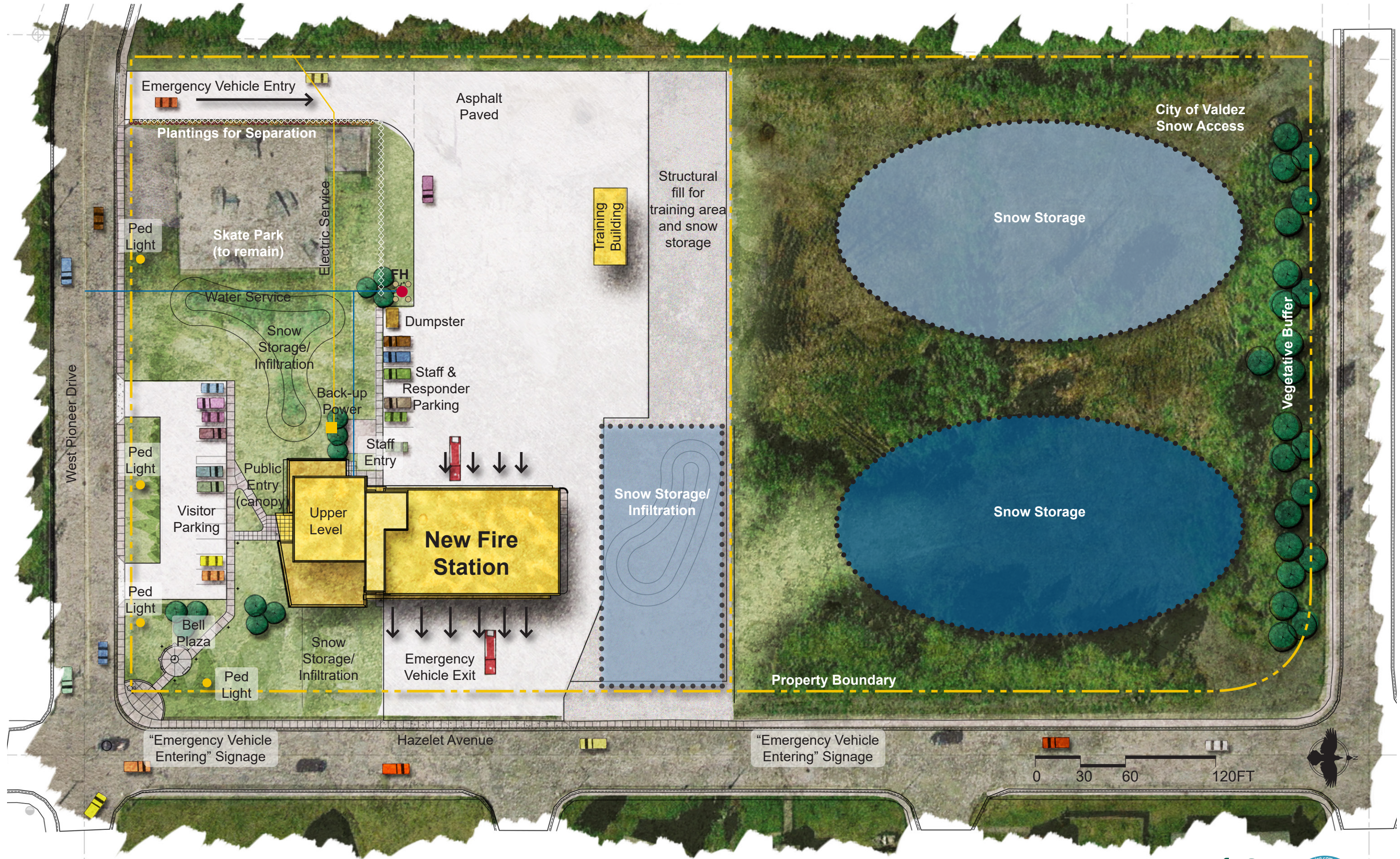


R2_ SLOPED ROOF ASSEMBLY

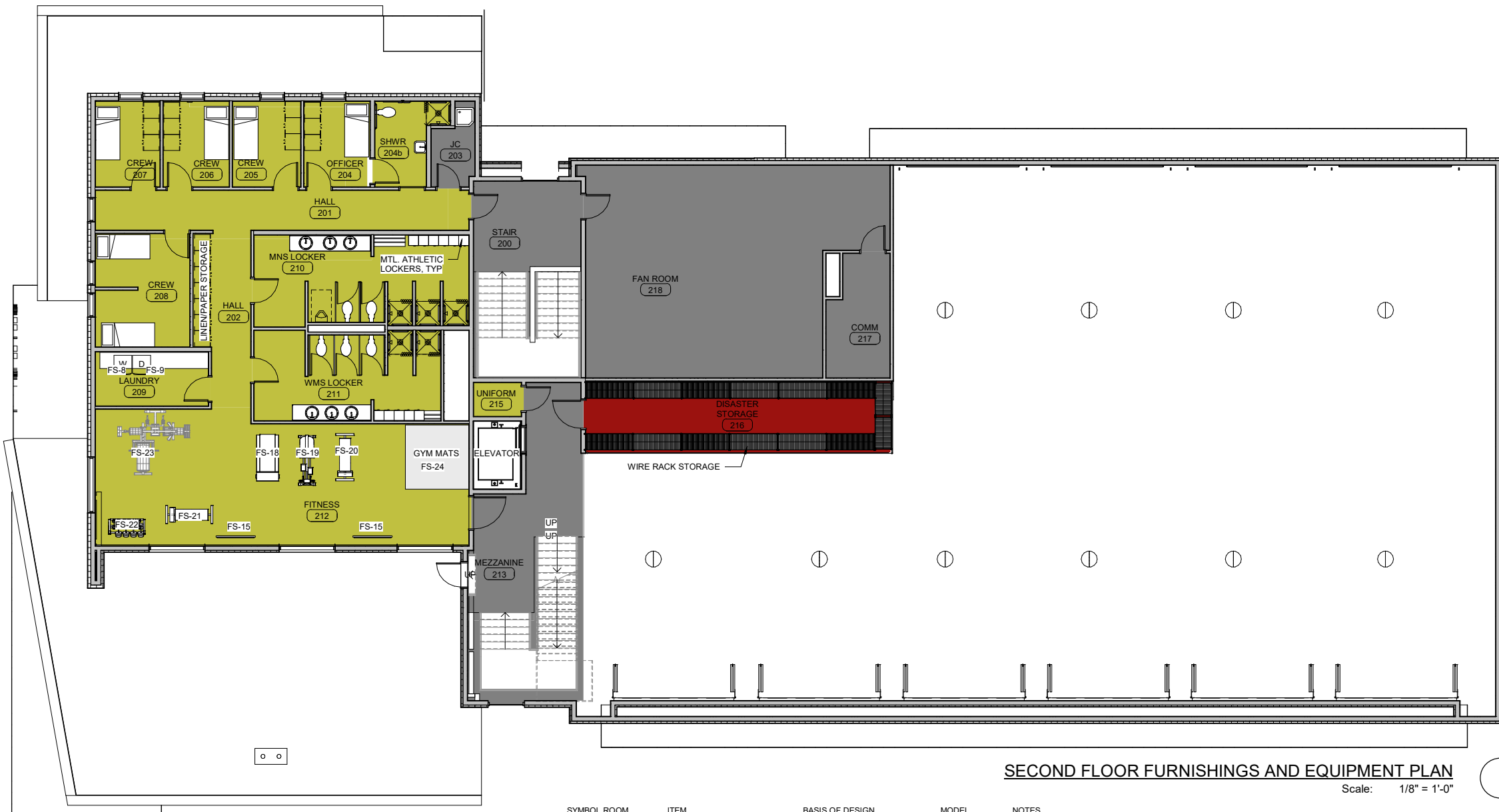


2 ALTERNATE PLAN - EOC LAYOUT

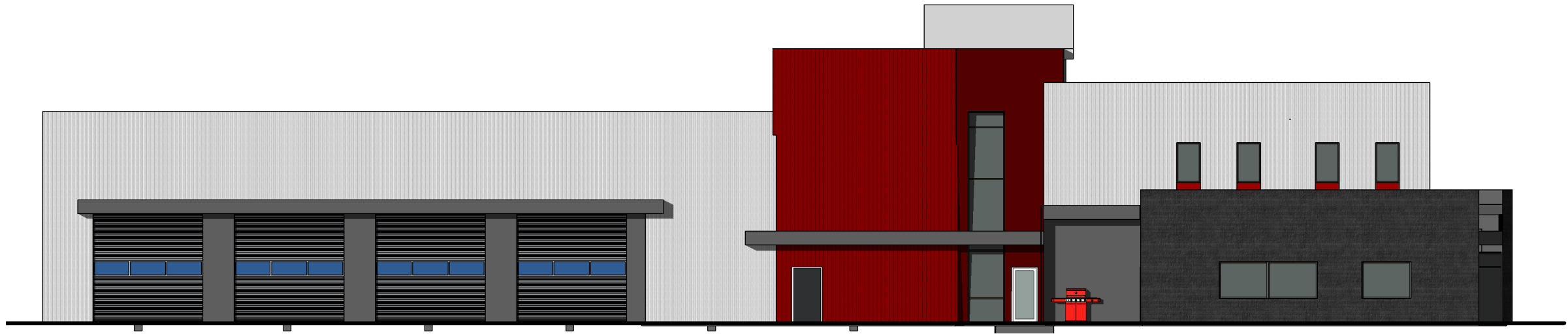

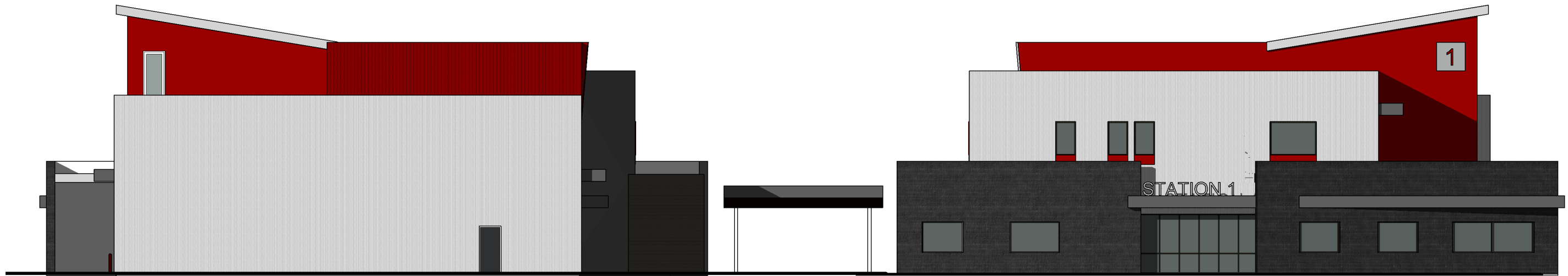

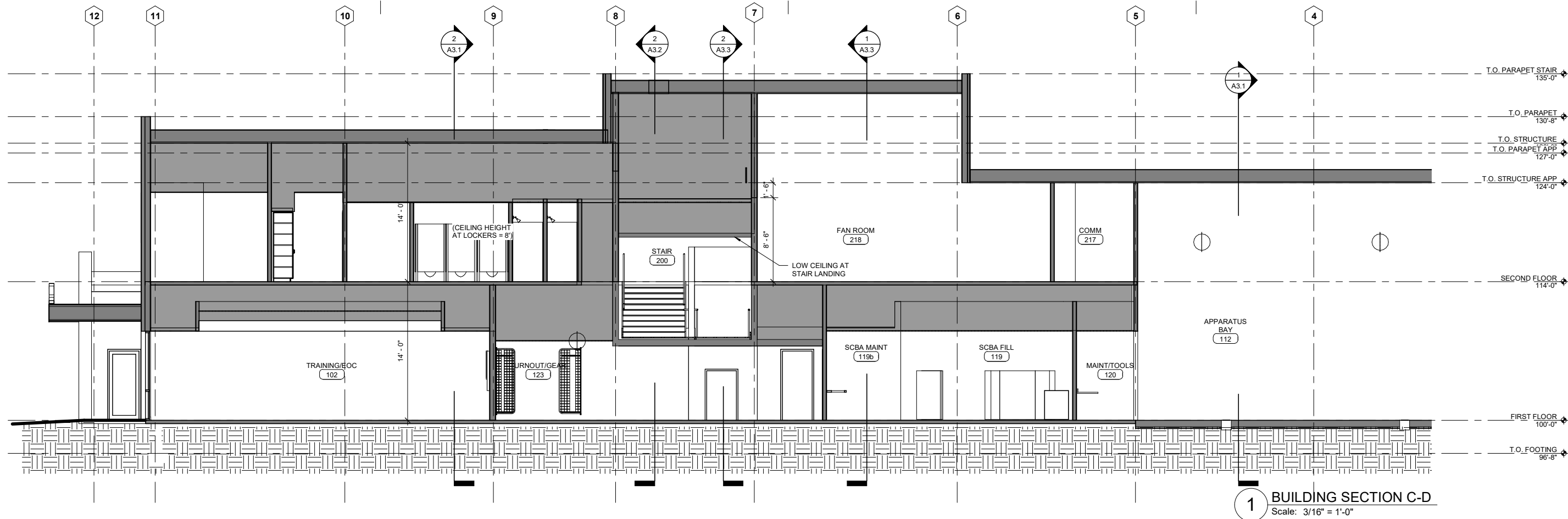


4 NORTH ELEVATION - COLOR

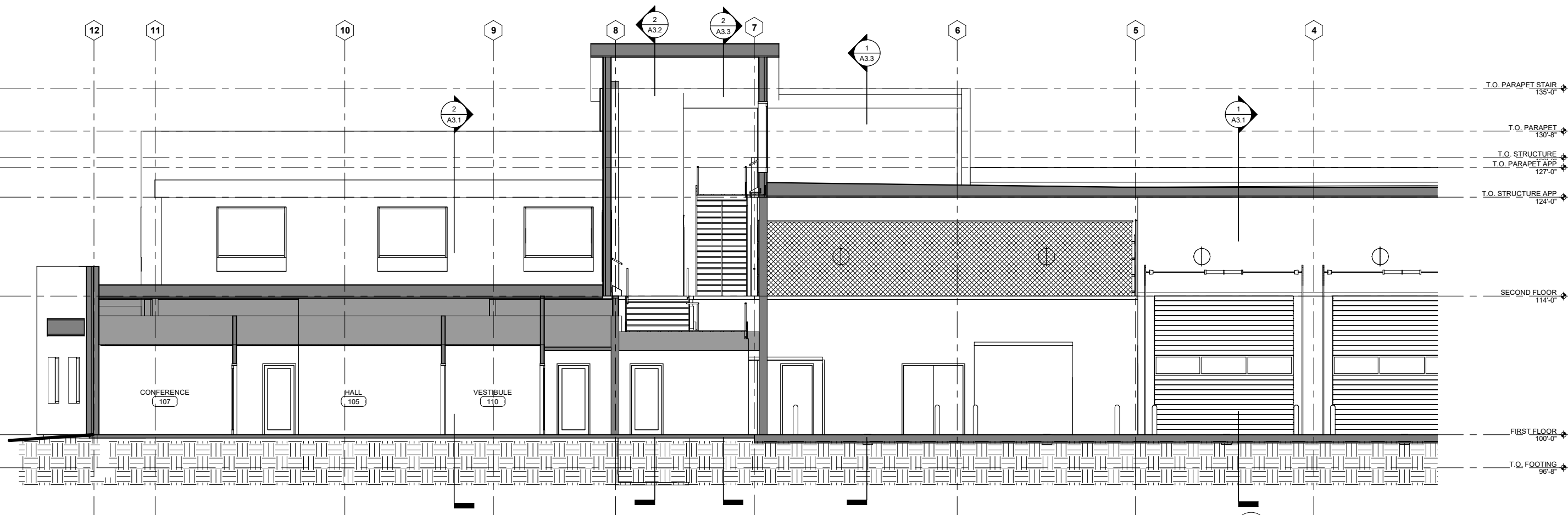
