

AN EASEMENT 15 FEET WIDE OFF THE NORTHWEST AND NORTHEAST BOUNDARY OF ROBE RIVER SUBDIVISION DESCRIBED AS FOLLOWS:

BEGINNING AT THE TRUE POINT OF BEGINNING BEING THE NORTHERN MOST CORNER OF ROBE RIVER SUBDIVISION ACCORDING TO PLAT 69-37M VALDEZ RECORDING DISTRICT FURTHER DESCRIBED AS ALSO BEING CORNER 2 OF UNITED STATES SURVEY 3538; COMMON NORTHERN CORNERS OF LOTS 5 AND 6 OF BLOCK 13 OF SAID ROBE RIVER SUBDIVISION AND THE WESTERN CORNER OF TRACT F2 OF A.S.L.S. 79-116 ACCORDING TO PLAT 96-11 AND THE SOUTHEASTERN BOUNDARY THE REMAINDER OF TRACT F A.S.L.S. 76-116 OF PLAT 81-11 VALDEZ RECORDING DISTRICT ALL WITHIN SECTION 12 TOWNSHIP 9 SOUTH, RANGE 6 WEST COPPER RIVER MERIDIAN;

THENCE SOUTH 42°01'00" EAST 2045.20 FEET ALONG THE NORTHEAST BOUNDARY OF BLOCKS 13, 12 AND 9 OF SAID ROBE RIVER SUBDIVISION TO THE RANGE LINE BETWEEN SAID SECTION 12 TOWNSHIP 9 SOUTH RANGE 6 WEST AND TRACT B SECTION 7 OF TOWNSHIP 9 SOUTH RANGE 5 WEST AS SHOWN ON A.S.C.S. 98-23 PLAT 2000-6 BEING THE CLOSING CORNER OF SAID SECTIONS ON THE NORTHEAST BOUNDARY OF SAID USS 3583;

THENCE SOUTH 42°01'32" EAST 1605.86 FEET WITHIN SAID TRACT B SECTION 7, ALSO BEING THE NORTHEAST BOUNDARY OF BLOCKS 9, 6 AND A PORTION OF BLOCK 1 OF SAID ROBE RIVER SUBDIVISION TO THE CLOSING CORNER OF SAID TRACT B SECTION 7 AND SECTION 18 AND SAID USS 3583;

THENCE NORTH 89°59'00" EAST 20.19 FEET ALONG THE SECTION LINE BETWEEN SAID TRACT B SECTIONS 7 AND 18;

THENCE NORTH 42°01'32" WEST 1636.02 FEET WITHIN SAID TRACT B SECTION 7 TO THE RANGE LINE BETWEEN SAID TRACT B SECTION 7 T. 9 S. R. 5 W. AND SECTION 12 T. 9 S. R 6 W. C.R.M.;

THENCE NORTH 42°01'00" WEST 2043.57 FEET WITHIN SAID TRACT F A.S.L.S. 79-116;

THENCE SOUTH 47°54'30" WEST 14.99 FEET WITHIN SAID TRACT F A.S.L.S. 79-116 TO THE NORTHEASTERN BOUNDARY OF SAID TRACT F2 A.S.L.S 79-116;

THENCE SOUTH 47°54'30" WEST 660.66 FEET WITHIN SAID TRACT F2;

THENCE SOUTH 42°05'30" EAST 15.00 FEET WITHIN SAID TRACT F2 TO THE NORTHWEST BOUNDARY OF SAID BLOCK 13 ROBE RIVER SUBDIVISION;

THENCE NORTH 47°54'30" EAST 660.69 FEET ALONG THE NORTHWESTERN  
BOUNDARY OF SAID BLOCK 13 ROBE RIVER SUBDIVISION TO THE TRUE POINT OF  
BEGINNING.
