2. Approval of Temporary Land Use Permit #19-02 for Karen Ables for Fat Mermaid Restaurant for Six Months on 600 Square Feet of Public Right of Way Immediately Adjacent to Lot 1A, Block 39A, Harbor Subdivision

MOTION: Commission Member Haase moved, seconded by Commission Member Kipar, to approve the Temporary Land Use Permit #19-02 for Karen Ables for Fat Mermaid Restaurant for Six Months on 600 Square Feet of Public Right of Way Immediately Adjacent to Lot 1A, Block 39A, Harbor Subdivision. The motion carried by the following vote after the following discussion occurred.

Commissioner Blehm asked if the proposal was the same as Karen Ables had put forward last year and asked when the next meeting for the Waterfront Master Plan would be. He stated that parking and the need for outdoor restaurant seating was an ongoing issue and wanted to make sure that is was discussed in the Waterfont Master Plan. He also discussed road access and issues related to it. Ms. Rollenhagen addressed the Commissioners and stated that Ms. Ables would be required to comply with the Americans with Disabilities Act. V. COMMISSION BUSINESS FROM THE FLOOR

Commissioner Kipar discussed the need for a gravel extraction master plan. He went on to discuss the Valdez Glacier Lake area and issues related to the flooding each year. Commissioner Blehm encouraged people to attend the next Waterfront Master Plan meeting. He then mentioned the recent KCHU interview that Mayor O'Neil and Council Member Moulton had done. Commissioner Wade wanted to make sure that notification was done to the applicants that were on the agenda. She then asked about land availability. Director Rollenhagen stated that an RFP would be presented to the Economic Development Commission for review before it would be presented to City Council. She thanked Commissioner Blehm for reminding everyone of the Waterfront Master Plan Monday at 7PM at the Civic Center. She then told all the members that they were eligible for vests and if they wanted one to call the department with their sizes. Kimley-Horn would be in town May 20th and 23rd and would be presenting information to Council.
