

# Public Safety (Dispatch / Corrections):

Three (3) Public Safety Technicians were hired in 2019, two of which are fully cross-trained to perform Dispatch and Corrections duties. The training hours invested in the three employees thus far is approximately 1,000 hours. Other trainings for the year included (2) employees in APSIN training, (3) employees certified in Emergency Medical Dispatch, (8) employees certified in Time Accounting for Corrections, (2) employees attended BI Total Access training for Electronic Monitoring Equipment and Software, (2) employees attended the annual Spillman Technologies Conference for Computer Aided Dispatch, and one employee volunteered to be a CISM team member.





## Animal Control

- 197 Animals out (110 adopted, 87 returned to owner)
- 2 orphan Brown Bear cubs transferred to Alaska Zoo for re-homing

- 4 dogs, 9 cats received from cooperating agencies (crisis assistance)

## Code Enforcement

- Vehicle Abatement Program:
  - 140 Vehicle Removal memos received
  - o 118 Vehicle Removal memos dispatched
- 28 Code Enforcement Cases (12 cases resulted in abatement)
  - Breakdown:
    - 6 Initial Voluntary Compliance Agreement cases
      - 1 initial VCA case in full compliance
      - 5 other VCA cases resulted in issue of Notice and Order of Abatement
    - 7 Total Notice and Order of Abatement cases
      - 4 NOA cases are in full compliance
      - 3 NOA cases are ongoing
    - 1 call referred to the Building Inspector
    - 3 cases with no VCA or NOA issued
      - (1) working with property owner to have renter come into compliance
      - (1) being handled by Legal
      - (1) under investigation
    - 1 case involved a conversation with property owner, who immediately came into compliance
    - 1 initial VCA, followed by NOA, resulted in the demolition of the unsafe structure
