This Ordinance amends Chapter 9.38 to simplify land use regulations related to trapping activities within the City of Valdez in order to protect the health and safety of persons and pets.

#### CITY OF VALDEZ, ALASKA

#### ORDINANCE NO. 20-05

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, AMENDING CHAPTER 9.38 OF THE VALDEZ MUNICIPAL CODE TITLED TRAPPING

WHEREAS, the following amendments to Chapter 9.38 of the Valdez Municipal Code establish regulations related to land use as it pertains to trapping activities within the City of Valdez.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, THAT, the following amendments are made to Chapter 9.38 of the Valdez Municipal Code:

SECTION 1. Chapter 9.38 is hereby amended to read as follows:

#### Chapter 9.38

#### **TRAPPING**

Sections:	
9.38.010	Purpose of chapter.
9.38.020	Definitions.
9.38.030	Trapping allowed.
9.38.040	Qualifications to trap.
9.38.050	Identification of traps.
9.38.060	Registration.
9.38.070	<del>Unsafe traps.</del>
9.38.0 <u>4</u> 80	Other exceptions.
9.38.0 <u>5</u> 90	Violation—Penalty.

#### 9.38.010 Purpose of chapter.

It is the purpose of this chapter to <u>enact land use regulations pursuant to AS</u>
<u>29.35.260(c) to</u> protect <u>all persons</u> the citizens from hazardous devices and to protect domesticated animals and pets from damage and destruction which may result from uncontrolled trapping <u>activities</u>.

#### 9.38.020 Definitions.

The following words and phrases shall have the meanings respectively ascribed to them by this section:

"Trap" means any device used for the purpose of catching, capturing, snaring, holding or killing animals.

"Trapping" means the placing or setting of traps with the intent to catch animals. This definition does not apply to the catching of animals within a dwelling place or garage, shed or barn.

#### 9.38.030 Trapping allowed.

Trapping for both recreational and for subsistence purposes is allowed within the Valdez city limits except that:

- A. Trapping shall not be allowed within one-half mile in any direction of an occupied subdivision.
- B. Trapping shall not be allowed within five hundred feet of any road, excluding bridges and culverts outside the downtown area and past the duck flats. No trapping is allowed within the area known as the Valdez duck flats, which is defined as that area bounded on the east by Mineral Creek Loop Road, on the west by the Richardson Highway, on the south by a line extending from the Valdez Container Terminal to and including Dock Point and on the north by elevation of one thousand feet.
- C. <u>Trapping shall not be allowed</u> Snare-only trapping areas shall include within portions of Mineral Creek Canyon and all areas northeast of the Richardson Highway from Airport Road to the Glacier Stream Bridge. No trapping is allowed within five hundred feet of the Mineral Creek trails, located in Mineral Creek Canyon as designated on Exhibits A and B to Section 12.08.010.
- D. No trapping is allowed within the area known as Mineral Creek State Park, which is defined as a fifty-acre parcel known as Tract A-2, ASLS 99-21; and a 91.68-acre portion of U.S. Survey 5113 bounded on the north by Raven Subdivision and Tract A-1, ASLA 79-117, on the east by Tract A-1, ASLA 79-117, on the south by Blueberry Subdivision and Port Valdez, and on the west by Tract A-2, ASLA 99-21.

#### 9.38.040 Qualifications to trap.

All persons who trap within the Valdez city limits shall show proof of completion of an approved trapping safety class conducted by the city of Valdez animal control department and valid trapper's license. Copies of trapping licenses shall be provided to the city of Valdez animal control department.

#### 9.38.050 Identification of traps.

- A. All traps shall include a permanent metal tag on which is stamped or etched the trapper's name and phone number.
- B. All traps and all trap lines shall be marked with a legible warning signappropriately set and height-adjusted (i.e., for snow level). Said signs shall be clearlyvisible on a weather-resistant surface and with the numbers and letters, at least one inch high, in a bright fluorescent color that contrasts with the color of the sign. Eachtrapper is responsible for placement and maintenance of proper signage.

#### 9.38.060 Registration.

All trappers shall register the exact locations of their trap lines with the city of Valdezanimal control department. If requested, this information will be made available to the public.

#### 9.38.070 **Unsafe traps.**

Any traps deemed unsafe by a law officer will be removed immediately. The law officer shall attempt to notify the owner of the trap.

#### 9.38.0480 Other exceptions.

The chief of police or the chief's designee shall have the absolute authority to authorize trapping within a restricted area within the Valdez city limits as is deemed necessary to protect public health and safety. Examples of exceptions include, but are not limited to, the following:


- A. Employees or agents of governmental units or agencies who, using live traps, in the course of their duties, are required to trap animals or birds for authorized purposes.
- B. Scientists in their work of identifying and studying wildlife, animals and birds for scientific purposes.
- C. Persons who have specific animal nuisance problems.

#### 9.38.0590 Violation—Penalty.

Violation of Sections 9.38.010 through 9.38.0370 is punishable by a minimum fine of fifty dollars. Upon citation under Sections 9.38.010 through 9.38.0370, court appearance is mandatory.

<u>Section 2.</u> This ordinance shall take effect immediately upon passage and approval by the Valdez City Council.

Thirty-four (34) of the forty-eight (48) VFDs will receive some level of funding. A total of \$225,000 was awarded. This letter is the official notification.

The enclosed spreadsheet lists all applicants and amount requested/amount awarded. If a fire department was awarded a grant, the amount awarded will be listed in the column titled "Amount Awarded". Some VFDs will not receive an award this year and two will receive a partial award. If a VFD did not receive any funding or will be receiving a partial award, please contact your respective DOF Fire Management Officer with any questions you may have.

- Checks will be distributed electronically by association with the VFD's SOA vendor number and the SOA electronic payment agreement. Electronic disbursements are expected sometime in the next four-six weeks.
- To be eligible for a 2021 VFA grant, compliance documentation, such as copies of receipts for 2020 grant expenditures, must be submitted to your nearest Forestry office at the time of, or prior to, submitting a 2021 application.
- Volunteer Fire Assistance is an award of Federal Financial Assistance with funding from the USDA Forest Service. Prime and sub recipients to this award are subject to OMB guidance in sub parts A through F of 2 CFR Part 200 as adapted and supplemented by the USDA in 2 CFR Part 400. Adaption by USDS of the OMB guidance in 2 CFR 400 gives regulatory effect to OMB guidance in 2 CFR 200 where full text may be found.

### **SUMMARY STATEMENT:**

On April 3, 2020, Planning Department staff received a temporary land use permit application from Copper Valley Telecom for use of 5345 Chalet Drive, Lot 20, Block 7, Alpine Woods Subdivision owned by the City of Valdez. Copper Valley Telecom has requested use of the parcel for storage of fiber optic cable, utility conduit, excavation equipment, and an 8' x 30' temporary office trailer in conjunction with the installation of fiber optic internet in Alpine Woods Subdivision (see attached application.) The requested area is 41,806 square feet and is seasonally used as a snow removal lot. During the rest of the year, it is vacant. Copper Valley has requested use of the property for five months.

Public Works Director Rob Comstock was solicited for comments on the application and expressed no objection to the use proposed.

Per Valdez Municipal Code 17.48.140 B 2 e, temporary land use permit requests not to exceed six months in duration may only be granted by the Planning and Zoning Commission if the desired use is in conformance with the existing zoning and/or comprehensive plan. In reviewing temporary land use permit application 20-02, staff determined the use requested by Copper Valley to be in accordance with the comprehensive plan goal to provide the maximum range of community services and facilities, especially on a short term and temporary basis.

On April 22, 2020 the Planning and Zoning Commission voted to approve temporary land use permit 20-03. Per Valdez Municipal Code 17.48.140 B2k, this decision is reported to City Council. If there is no objection from Council tonight, staff will prepare a temporary land use permit document using standard language approved by the City attorneys





### <u>CITY OF VALDEZ</u> TEMPORARY LAND USE PERMIT AGREEMENT

#### Permit No. 20-03

This Temporary Land Use Permit Agreement (hereinafter referred to as Permit) is entered into this \_\_\_\_th day of April, 2020 by and between the CITY OF VALDEZ, an Alaska municipal corporation (hereinafter referred to as "Valdez"), whose address is P.O. Box 307, Valdez, Alaska, 99686, and COPPER VALLEY TELECOM, (hereinafter referred to as "Permittee"), whose address is P.O Box 337, Valdez AK 99686. This Permit was approved by the Valdez Planning and Zoning Commission on the 22nd of April, 2020 and was reported to the Valdez City Council with no objection on the \_\_ day of \_\_\_\_, 2020.

#### WITNESSETH:

1. <u>Permit</u>. Valdez hereby grants to Permittee the right and privilege to be present upon the following described real property belonging to Valdez pursuant to the terms of this Permit Agreement:

# Lot 20, Block 7, Alpine Woods Subdivision (See Exhibit "A")

- 2. <u>Term and Termination</u>. Permittee may use the Property for the purposes set forth herein beginning on the <u>\_\_day of \_\_\_\_</u>, 2020 and continuing until the <u>\_\_day of \_\_\_\_</u>, 2020. In no circumstance shall this Permit exceed six months in duration. The City of Valdez, may at its sole discretion terminate this Permit at any time for any reason with 30 days' written notice to Permittee. Permittee shall vacate the property within thirty days from receiving written notification from the City of Valdez.
- 3. <u>Use</u>. Permittee shall use the Property for the temporary storage of cable reels associated with the installation of fiber optic internet in the surrounding area and for no other purpose whatsoever without the prior written consent of the City of Valdez. Use of the Property under this Permit shall conform with existing City of Valdez zoning requirements and the City of Valdez

comprehensive plan. Use of the Property under this Permit shall not adversely impact public access or Valdez operations. No permanent structures shall be erected on the property; and no permanent alteration of the land shall occur.

- 4. <u>Permittee Not a Lessee</u>. No legal title or leasehold interest in the Property shall be deemed or construed to have been created or vested in Permittee by anything contained herein. The purpose of this permit is to convey a non-possession interest by the City of Valdez to Permittee in that certain property (not to exceed two acres) described in paragraph 1 above. The City of Valdez shall maintain all right, title, and interest in that Property as fee simple owner thereof, and Permittee by virtue of this Permit has only the right and privilege to be present upon the Property and to make use of it for the purpose set forth in paragraph 3 above.
- 5. <u>Fee</u>. In consideration for use of land owned by the City of Valdez, Permittee agrees to pay in advance a lump sum equal to a flat monthly fee of two hundred fifty dollars (\$250.00) per month of occupancy plus a pro-rated daily rate of nine dollars (\$9.00) per day for the number of days this permit is in effect other than a full month.
- 6. <u>Insurance Requirement</u>. The Permittee shall, at its own expense, maintain and keep in force during the terms of this Permit adequate insurance to protect both the City of Valdez and Permittee against comprehensive public liability claims arising from the use of the property in the minimum limit of ONE MILLION DOLLARS (\$1,000,000) combined single limit to protect against liability for personal injury, death, or property damage. The Permittee shall deposit with the City of Valdez a copy or copies of such insurance coverage together with appropriate evidence that the premiums thereupon have been paid. All such insurance of the Permittee shall name the City of Valdez as an additional insured party and contain a waiver of subrogation endorsement and provide that the City of Valdez shall be notified at least thirty (30) days prior to any termination, cancellation, or material change in such insurance coverage. Such requirement for insurance coverage shall not relieve the Permittee of any of its other obligations under this Permit.
- 7. <u>Maintenance</u>. Permittee agrees to maintain the property in a neat and orderly fashion. Upon termination of this Permit, Permittee agrees to leave the premises in a neat and clean condition.
- 8. <u>Mechanic's Liens</u>. Permittee shall pay all costs for construction done by it or caused to be done by it on the Property as permitted by this Permit. Permittee agrees not to construct any permanent structures on the property.
- 9. <u>Utilities</u>. Permittee shall be solely liable for and shall timely pay when due all expenses and fees for all utilities used or consumed with respect to the Property. The Permittee shall be required to provide and maintain sanitary facilities to include, but not be limited to, port-a-potties and garbage dumpsters.
  - 10. Exculpation of Valdez. Valdez shall not be liable to Permittee for any damage to

Permittee or Permittee's property from any cause. Permittee waives all claims against Valdez for damage to persons or property arising from any reason.

- 11. <u>Indemnity</u>. Permittee shall hold the City of Valdez harmless from and against any and all damages arising out of any damage to any persons or property occurring in, on, or about the Property.
- 12. <u>Condemnation</u>. If during the term of this Permit there is any taking by condemnation of the Property or any interest in this Permit, this Permit shall terminate on the date of taking. Any condemnation award shall belong to and be paid to The City of Valdez, and Permittee hereby assigns to the City of Valdez Permittee's interest therein.
- 13. <u>No Encumbrance or Assignment Permitted.</u> Permittee shall not voluntarily encumber its interest in this Permit or in the Property or attempt to assign all or any part of the Property, or allow any other person or entity, except its authorized representatives, to occupy or use all or any part of the Property.
- 14. <u>Default</u>. The occurrence of any of the following shall constitute a default under this Permit by Permittee:
- (a) Failure to pay fees when due, if the failure continues for fifteen (15) days after written notice for payment;
- (b) Any default in or failure to perform any term, covenant, or condition of this Permit including those set forth in Exhibit B;
- (c) The cessation by Permittee of the operation of the Permittee's business located on the Property for a period of thirty (30) days;
- (d) The making of any assignments for the benefit of creditors of Permittee, the appointment of a receiver for Permittee's business, the entry of an Order for Relief as to Permittee under the United States Bankruptcy Code as now in effect or hereafter amended, the insolvency of Permittee, or any similar situation.
- 15. <u>Remedies</u>. In the event of any default by Permittee under the provisions of paragraph 14 of this Permit, all of Permittee's rights hereunder shall immediately terminate; and the City of Valdez may, in addition to any rights and remedies that it may be given by statute, common law, express agreement, or otherwise, enter and take sole possession and control of the Property.
- 16. <u>Valdez' Entry on Premises</u>. The City of Valdez shall have the right to enter the Property at any time and, in view of the fact this Permit constitutes a license on real property rather than a lease, shall at all times remain in possession of the Property.

- 17. <u>Notices</u>. Any notice, demand, request, consent, approval, or communication that either party desires or is required to give to the other party or any other person shall be in writing and either served personally or sent by certified mail, return receipt requested, and shall be addressed to the other party at the address set forth in the introductory paragraph of this Permit. Either party may change its address by notifying the other party of the change of address. Such notices shall be deemed given when mailed irrespective of whether or not they are received.
- 18. <u>Modification, Amendment, Waiver</u>. No delay or omission in the exercise of any right or remedy of the City of Valdez on any default by Permittee shall impair such a right or remedy or be construed as a waiver. No modification, amendment, or waiver of any of the provisions of this Agreement shall be effective unless in writing, specifically referring hereto, and authorized by both parties.
- 19. <u>Governing Law/Jurisdiction</u>. This Permit shall be governed by, interpreted, and enforced in accordance with the laws of the State of Alaska and the laws of the United States, as applicable. The venue for all litigation arising out of or relating to this Agreement shall be Valdez, Alaska. The parties hereto irrevocably agree to submit to the exclusive jurisdiction of such courts in the State of Alaska and waive any defense of *forum non conveniens*.
- 20. <u>Miscellaneous</u>. Time is of the essence with respect to each provision of the Permit, and it shall be binding upon and inure to the benefit of the parties, their heirs, assigns, and successors in interest. The enforceability, invalidity, or illegality of any provisions of this Permit shall not render the other provisions of this Permit unenforceable, invalid, or illegal.


