#### **SUMMARY STATEMENT:**

- This one-hour workshop is the annual Permanent Fund discussion with Council.



As of June 30, 2021



- Annual distribution to the General Fund = 1.5%, or approximately \$4.1MM
- Long-Term Permanent Fund growth objective = CPI + 4.0%, or approximately \$16.5MM
- Permanent Fund Policy: 50% Stocks, 40% Bonds, 10% Real Estate



# Growth of a Dollar For 24 Years Ended June 30, 2021






# Annual Appropriations at 6.6% Growth
